### 4. First aid measures

#### 4.1. Description of first aid measures

##### General

Move victim to fresh air.  
Call 911 or emergency medical service if deemed necessary.  
Give artificial respiration if victim is not breathing.  
Administer oxygen if breathing is difficult.

##### Skin

##### Ingestion

### 6.3. Methods and material for containment and cleaning up

Remove sources of ignition, do not turn lights or unprotected electrical equipment on or off. In case of a major spill or spillage in a confined space evacuate the area and check that solvent vapor levels are below the Lower Explosive Limit before re-entering.

**Large Spill:** As an immediate precautionary measure, isolate spill or leak area for at least 50 meters (150 feet) in all directions.

Keep unauthorized personnel away. Stay upwind.

Keep out of low areas.

Ventilate closed spaces before entering.

## 7. Handling and storage

### 7.1. Precautions for safe handling
